REPORTS CITY MANAGER

Updates:

OLD BUSINESS

Resolution to Award Street Work Contracts: As I noted above, the Finance Committee will be meeting on Monday at 4:00 pm to review the bids for the three street projects (Paving, Seal Coating & Street Markings). At the time of this memo we have received 2 Pavement Marking Bids and one Seal Coat bid, but they aren't due until 1:00pm & 2:00 pm on Tuesday the 14th. As we talked about at the last meeting, there was 1 bid received for the paving work.

We will hopefully have a recommendation for you at the meeting on Monday night as to which bids we will award.
